NOTICE OF PRIVACY

RESPONSIBLE FOR PROTECTING YOUR PERSONAL INFORMATION

According to the "Ley Federal de Protección de Datos Personales en Posesión de Los Particulares" (hereafter addressed as "LAW") Retail ESPMAC Mexico S.A. de C.V. (hereafter addressed as "RESPONSIBLE") located in Paseo de las Palmas number 735, 8th floor, Lomas de Chapultepec, Miguel Hidalgo, Mexico City, CP 11000, convinced of protecting their user's information (hereafter addressed as "PERSONAL DATA") and as the responsible of its use while being collected through the website https://grupoicem.com/ (hereafter addressed as "WEBSITE"), printed media and/or via telephone (hereafter addressed as "OTHER MEDIA").

PERSONAL DATA THAT WILL BE SUBJECT TO TREATMENT

The personal data that will be subject to treatment by the RESPONSIBLE and that will be collected through the website, personally, or Other Media are:

- <u>Personal identification information:</u> full name, last name, and address.

CONSENT

If the Responsible, by an involuntary or technical mistake or caused by the information owner's inadvertence would happen to collect the minor/incapable's information, the information will be permanently deleted from any database as soon as this situation is acknowledged.

INFORMATION TREATMENT'S PURPOSE

1- The purposes that give rise to and are necessary for the existence, maintenance, and fulfillment of the legal relationship between the controller and you, are the following:

MEANS AND PROCEDURES FOR EXERCISING RIGHTS OF ACCESS, RECTIFICATION, CANCELLATION, AND OPPOSITION (ARCO).

The owner or user has the right to exercise any of the Access, Rectification, Cancellation, or Opposition rights provided in the Law, through the following means:

MECHANISM AND PROCEDURE FOR REVOKING CONSENT TO THE PROCESSING OF PERSONAL DATA.

You may revoke your consent at any time without any retroactive effects, which can be done through the means and procedures implemented by the Responsible.

USE OF MECHANISMS IN REMOTE OR LOCAL ELECTRONIC COMMUNICATION MEANS (COOKIES AND WEB BEACONS)

No personal data is collected through our website's cookies or beacons.

<u>Cookies definition</u>: A cookie is a piece of data from a website that is stored within a web browser that the website can retrieve later. Cookies are used to tell the server that users have returned to a particular website. When users return to a website, a cookie provides information and allows the site to display selected settings and targeted content. Cookies also store information such as shopping cart contents, registration or login credentials, and user preferences. This is done so that when users revisit sites, any information provided in a previous session or set preferences can be easily retrieved.

<u>Web beacons definition:</u> A web beacon is a small image file used for tracking purposes. It may be placed in a webpage or HTML email to record when the content was loaded. Each image referenced within a webpage is retrieved from a server. When the image is loaded, the server records a "hit," which is typically saved in the server log. A log file on the server can be used to determine when the specific image was accessed and the IP address that accessed the file.
